## GRANTS

## Supports Given by Ministry of Agriculture and Forestry

### Supporting Rural Development Investments

Within the scope of this support, it is planned to support investments made by real and legal persons in economic activities in order to ensure economic and social development in rural areas.

#### Purpose of the Support

The purpose of this support is; to increase income level in the rural area by considering natural resources and protection of the environment, to support family businesses and small and medium-sized enterprises in order to ensure industrial integration based on agricultural production and agriculture, to develop agricultural marketing infrastructure, to strengthen food safety, to create alternative income sources in rural areas, to strengthen rural economic infrastructure, to make producers use new technologies developed for agricultural activities in a widespread manner, to increase effectiveness of rural development activities that are being carried out, to support new technology investments and individual irrigation systems to contribute to building local development capacity in rural society.

#### Who can benefit from it?

Real and legal persons (companies, cooperatives for agricultural purposes, associations and their supreme boards) that are already registered in register systems created by the Ministry, can apply for this support. Young entrepreneurs (Ages 18-41) and women are prioritized for investment areas.

#### Subjects and Rates of Investment

The items listed in the following table are supported at the rate of 50% up to the limit that is indicated:

Detailed investments and individual irrigations systems are supported for such conditions:

- New investments
- Complement of partly completed investments
- Capacity increase, modernization and/or technology renewal investments

Conditions differ according to the type of investment and provinces. For details, notification numbered 2023/51 should be checked.

#### Supported Costs

- Construction works purchase expenses (covers inevitable costs for enabling the project to be put into practice)
- Machinery, equipment and material purchase expenses (in case of being a part of the whole project)

#### Costs that are not supported

- Live animal purchase
- Transformer purchases
- Generator purchases outside of the ones for new facilities
- Borrowing expenses and interests
- Rent expenses
- Land, estate, building purchase prices
- Fuel, water, electricity and fee expenses
- Taxes that will be or won't refunded, including VAT
- Second hand good purchase expenses
- Machine repair and parts purchase expenses

#### Place and Date of Application

Supported items vary depending on the period and province. All or some of the specified investment areas are determined by the Ministry according to the sectoral priorities of the provinces and announced before the application guide to be published every year on November. Applications are done online. The actual registration and provision of information are performed by Provincial Directorates of Ministry of Agriculture and Forestry. For details, notification numbered 2023/51 should be checked. For 2024, latest application date is 19 February 2024.

#### Other Statements Related to the Support

• Support is given by means of grant for 50% of grant based project amount. Applicants are obliged to provide the remaining 50% of the amount on their own. Payments are made after purchase.

- Project budget is prepared excluding VAT (Value Added Tax).
- The grant based project amount should be minimum 3,000,001 TL. For economic infrastructure investment areas, this amount is 100,000 TL.
- Investments on rental areas are possible. Minimum 7 years of rent term is necessary for land rentals after the last payment.
- Within the scope of processing agricultural products, the investment proposals for secondary processing and packaging of the goods subjected to first processing at another investment facility or products produced in abroad are not considered within the scope of the grant support. (Except for nuts)
- New investment and partly completed facility applications for flour, feed and unseed cotton facilities are not accepted.
- Construction expenses can't be more than 80% for new facility/completion investments, 60% for capacity increase investments and 20% for modernization investments of grant based project amount excluding steel silo, indoor plant production, cold storage and livestock investments.
- For all investments where geothermal, biogas, solar and wind energy will be used as the renewable energy source, the grant support is provided if the facility with renewable energy production or the facility to be established within the scope of this support will supply minimum 51% and maximum 110% of the energy requirement calculated through the installed capacity of the facility. (Off-grid investments are allowed in rural economic infrastructure investments.)
- Except fisheries, the grant based project expenses of new investment applications can't only consist of expenses for purchasing machines and equipment. However, for the project proposals related to completement, capacity increase and/or technology renewal, the grant based project amount can completely consist of expenses for purchasing machines and equipment.
- In investments for storage of agricultural products, only steel silo and cold storage are considered within the scope of the grant.
- Rural economic infrastructure investments can only be applied in villages, towns, rural neighborhoods and settlements with a population of less than 20,000.

## Supporting Expert Hands in Rural Development

This support aims to support the entrepreneurship of vocational school, high school and university graduates and to contribute to employment.

#### Purpose of the Support

The aim of this support program is to contribute to the employment of the young population who graduated from vocational schools, high schools or universities that provide education on agriculture, animal husbandry, forestry, food and fishery products. The program also aims to increase agricultural production, yield and quality by supporting entrepreneurship in the aforementioned sections and encouraging these activities to be carried out by experts.

#### Who can benefit from it?

Graduates of vocational schools, high schools and universities that provide education on agriculture, animal husbandry, forestry, food and aquaculture can benefit from this support. Applicant must guarantee to live in rural areas/villages with a population of less than 20,000.

#### Subjects and Rates of Investment

Grants of up to 250,000 TL are paid to the specified project subjects:

a) Projects for animal production,

**b)** Projects for herbal, fertilizer and pesticide production,

c) Projects for aquaculture production,

d) Projects for production of geographically indicated products and traditional products,

**e)** Projects for the processing, storage and packaging of the products specified in subparagraphs a, b, c, d.

#### Supported Costs

New machinery, equipment, animal, construction and material expenses are supported costs. Applicants who will make bovine and ovine investment projects can only purchase livestock primarily from cooperatives, unions and real and legal entities/institutions that can issue purchasing documents. Matters related to eligible costs are specified in the application guide.

#### Costs that are not supported

Expenses made before the support agreement are not accepted. Rent, construction, land, building, fuel, water, electricity, transportation, installation, tax, used equipment, consultancy, machine repair and parts expenses are unsupported costs.

#### Place and Date of Application

Starting and ending dates of applications are determined in the application guide that is published online after the announcement of communique in official gazette. Support applications are made online via Ministry's dedicated website.

#### Other Statements Related to the Support

- The project budget is prepared excluding value added tax (VAT).
- The project must be completed in order for the support payment to be made.
- Newly purchased items cannot be sold, rented, or transferred without the approval of the project management for 3 years after the grant payment.
- This support can only be used once. Persons benefiting from other grants of the Ministry for the same investment project cannot benefit from this support.

• For detailed information, Notification numbered 2023/5 should be checked.

### Supporting Individual Irrigation Systems

This support aims to make producers use modern pressurized individual irrigation machines and equipment developed for agricultural activities in a widespread manner.

#### Purpose of the Support

The purpose of this support is; to ensure production with higher quality and in accordance with market demands and to support individual irrigation systems in order to increase the income level of producers in rural areas by making producers use modern pressurized individual irrigation machines and equipment developed for agricultural activities in a widespread manner.

#### Who can benefit from it?

Real persons, agricultural companies, irrigation cooperatives and agricultural development cooperatives that are registered Ministry's registration systems, can benefit from this support.

#### Subjects and Rates of Investment

In this support, 50% of the grant based good purchase amount excluding VAT is supported. Grant based good purchase amount can't exceed 3.000.000 TL. Application budgets are prepared excluding VAT. Supported investments are as follows:

- a) Installation of on-farm drip irrigation system,
- b) Installation of on-farm sprinkler irrigation system,
- c) Installation of on-farm micro sprinkler irrigation system,
- ç) Installation of on-farm underground drip irrigation system,
- d) Installation of Linear or Centre Pivot irrigation system,
- e) Installation of drum irrigation system,
- f) Installation of solar powered irrigation system,
- g) Solar energy systems for agricultural irrigation,
- ğ) Smart irrigation systems.

#### Supported Costs

- Products such as solar panel, pump, filter, control unit, main pipes and pipes on the sides, connection equipment, valves, dripper and sprinkler equipment
- On-site delivery and installation expenses (in case of issuing purchase invoice including purchase price)

#### Costs that are not supported

- All taxes refunded or to be refunded including debt payments, interests, VAT and SCT
- Machine and equipment rental values
- Transportation and training expenses
- Banking, education and audit expenses
- Second hand good purchase expenses

#### Place and Date of Application

Applications are accepted by Provincial Directorates of Agriculture and Forestry. Applications are made within 45 days from the date of publication of the application guide. Applications are accepted until 2025 every year. For detailed information, Notification numbered 2021/7 should be checked.

#### Other Statements Related to the Support

- Real persons and companies can apply with their own lands or renting lands for at least five years or more in investments specified in the paragraphs (a), (b), (c) and (ç) and for at least ten years or more in investments specified in the paragraphs (d), (e), (f), (g) and (ğ).
- Cooperatives can apply with their own lands or renting public lands for ten years or more.
- Installation of investments in paragraphs (a), (b), (c) and (ç) must be completed within forty five days and installation of investments in paragraphs (d), (e), (f), (g) and (ğ) must be completed within sixty days.
- Cost of transmission line from water source to irrigation area can be maximum 20% of the total cost.
- In solar irrigation systems, cost of solar energy system can be maximum 60% of the total cost.
- The applicant which includes only solar system, is excluded from the grant support.
- Ones who benefited from the irrigation loans of Ziraat Bankası A.Ş. and the Agricultural Credit Cooperatives can't apply for this support for the same area.

## Supporting Breeding Heifer Raising

Within the scope of this support, farmers are enabled to benefit from the relevant investment subjects in order to increase animal capacity and productivity.

#### Purpose of the Support

The purpose of this support is; to establish bovine enterprises raising breeding heifers, to provide breeding heifers needed by our country domestically, to increase productivity and quality in meat and milk production and to support investments that will enable the capital to remain within the country.

#### Who can benefit from it?

Real and legal persons who are members of Breeding Cattle Breeders Association and active cattle enterprises registered in TÜRKVET system and real and legal persons who want to raise breeding heifers, can apply for the support.

#### Subjects and Rates of Investment

Items listed in the table are supported at the rate specified. Upper limits of amounts for grant based investment subject are determined by the Ministry and notified to the provincial directorates. An enterprise is enabled to benefit from the support in a way to have a capacity consisting of 50 animals.

#### Supported Costs

• Constructions such as barn, manure pit, feed storage, silage pit are supported.

 Elements affecting appearance of the building such as works that affect carriers of the barn or change the gross construction area related to capacity increase, expanding window areas, converting them into doors, increasing the roof height, changing location or dimensions of elements such as windows and doors are supported.

#### Costs that are not supported

- Administrative buildings, caretaker houses, security booth, calf shack, roof repair, land grading and environmental structures are not considered within the scope of the support.
- Second hand feed mixer and manure scraper.

#### Place and Date of Application

Investors who want to benefit from this support apply to the provincial/local directorate in the place where they will make the investment within the period determined and announced on the web page by the Ministry every year.

#### Other Statements Related to the Support

- Support includes at least one of the following issues; capacity increase/rehabilitation project construction, animal purchase and machine and equipment purchase.
- Payments are made through bank. A service commission at the rate of 0,2% of the support amount is paid to the bank for execution.
- Public institutions and organizations and their partners can't benefit from the grant support within the scope of this support.
- Investors can benefit from credit or tax incentives.
- Grants aren't given to the investors who have benefited from other public institutions' and
  organizations' supports related to same subject in the form of interest and grant support
  (those who have benefited from animal purchase, barn construction or repair, feed mixer and
  manure scraper grant).
- Provinces where the investments determined within the scope of the decision will be supported, are determined by the Ministry every year.
- Heifers/buffalos purchased within the scope of the support can't be sold for 2 years except for force majeure.
- Heifers are obtained from heifer breeding centers, disease-free enterprises, General Directorate of Agricultural Enterprises, Agricultural Credit Cooperatives and their affiliates and breeder/producer organizations.
- For detailed information, Notification numbered 2022/36 should be checked.

## Program for Supporting Ovine and Bovine Business Investments

#### Purpose of the Support

The purpose of this support is to support investments to improve the infrastructure of existing bovine and ovine breeding enterprises, to increase productivity and quality in animal products and to transform them into modern livestock enterprises.

#### Who ban benefit from it?

Real and legal person breeders who have been active for at least 1 year and registered in the registration systems of the Ministry of Agriculture and Forestry can benefit from this support.

#### Subjects and Rates of Investment

Grant support is given for the construction/capacity increase/modernization of a barn with a capacity of minimum 10 maximum 50 female bovines, minimum 100 and maximum 300 female ovines. Purchase of tents for animal shelter, machinery, tools and equipment are also supported. The upper limit of the investment amount is notified to the provincial directorates by the Ministry.

#### Supported Costs

- Construction expenses
- Tent
- Feed preparation machine, manure scraper system, mobile milking machine, milk cooling tank, animal scratching unit, automatic drinker

#### Costs that are not supported

Administrative buildings, caretaker's house, guard hut, calf hut, simple repair, land leveling, retaining wall and surrounding structures are not supported. All kinds of materials/equipment to be used in construction works, tents for animal shelter, machinery, tools and equipment must be new and second-hand materials/equipment are not allowed.

#### Place and Date of Application

Applications are received between the dates to be determined by the General Directorate of Livestock. Applications for 2021 are accepted between 1-30 July. Applications are made to the Provincial Directorates of Agriculture and Forestry.

#### Other Statements Related to the Support

- Real or legal person investors whose applications are approved can benefit from each of the investment subjects once partly or completely.
- Investors who have previously benefited or will benefit from the same support subjects of other public institutions and organizations cannot apply for this support.
- Payments are done through Ziraat Bank.
- If project budget is above the upper limits, exceeding amount of the approved projects are covered by investor.
- During the call periods, the application guide is published on the website of the General Directorate of Livestock (HAYGEM).
- For detailed information, the communiqué numbered 2021/21 should be checked.

## Livestock Supports

Different livestock areas are supported within the scope of this program.

#### Purpose of the Support

The purpose of this support is; to develop livestock farming in our country, to increase healthy production and to ensure sustainability, to protect and improve domestic animal genetic resources in

their place, to keep registration systems up to date, to increase efficiency of livestock policies and to support breeders to fight against animal diseases.

#### Who can benefit from it?

Each support subject is grouped in a separate tables and eligible beneficiaries are specified under the relevant support subject.

#### Subjects, Rates of Investment and Relevant Statements

#### Bee Keeping Supports

Support is given per hive or colony in order to protect and develop bee keeping sector.

Payments are made per queen bee. They are enabled to benefit from breeder queen bee support up to 5% of the number of active hives in the enterprise. This number can't exceed twenty in total.

Farmers registered in Farmers Register System are enabled to benefit from the animal supports listed in the table in the amounts specified provided their programmed vaccines are completed.

#### Slaughter Support

This program supports breeders who slaughter male cattle (including buffalo) that are registered in the Ministry's registration systems, were born in the country and completed fattening period in slaughterhouses in accordance with the legislation.

Support is not paid for male cattle that are sent to obligatory slaughter and for male cattle whose carcass was decided to be disposed in the examination after slaughter.
Applications are made to associations of meat producers or provincial/district directorates.
For detailed information and specie chart, Notification numbered 2022/36 should be checked.

#### Mother Sheep, Mother Goat and Ram/Male Goat Support

Breeders who breed breeding sheep-goats, who are members of breeding sheep-goat breeders associations and whose animals are registered in the Ministry's registration systems, can benefit from this support.

- Age of animals that will benefit from the support must be at least 15 months old.
- For enterprises that received mother animal support in the previous year and increased the number of mother animals in support year, additional 200 TL herd growing and renewing support payment is made per animal in addition to previous support year's lambs and kids that reached mother animal qualification in the support year.
- Applications are made to the breeder associations until 2/12/2022. For detailed information, Notification numbered 2022/36 should be checked.
- Ram- male goat support is valid for animals purchased from the Ministry's breeding programs or from breeding programs at ram-goat centers established by the Ministry.

#### Supporting Angora Goat Breeding and Mohair Wool Production

#### Animal Disease Compensation Supports

Amounts of animals slaughtered compulsorily or killed under the supervision of an official veterinarian or veterinarian authorized by the Ministry as a result of determination of compensated diseases specified in the Compensation Regulation for Animal Diseases, amounts of animals killed due to compensated disease detected in slaughterhouses and animals that are determined by Official Veterinarian report that they died due to vaccination and serum administration performed by the official veterinarian or assistant health personnel under his supervision and veterinarian authorized by the Ministry with the aim of enabling protection against a disease that must be reported, are given to owners of the animals as animal disease compensation support. If a disease is detected, the removal of animal products, feed, substances and tools are handled in accordance with regulations and costs are paid as compensation.

As a result of glanders, bovine tuberculosis, bovine brucellosis, sheep and goat brucellosis, bird flu, African horse plague, bird flu diseases, values of animals are assessed within the scope of principles determined by the Ministry and they are slaughtered or killed conditionally. Decision of Value Assessment Commission is issued within the scope of the principles determined by the Ministry with the Compensation Regulation for Animal Diseases and kept in provincial/district directorate.

Within the scope of Compensation Regulation for Animal Diseases, prices of animal products, feed, substances and materials and all of their disposal, transportation and disinfection costs are given to owners of the animals as animal disease compensation support on the basis of amounts determined by the local value assessment commission.

**Note:** Compensation is not paid for animals belonging to official institutions and municipalities, for animals that referred by their owners as sick without documents specified by the Ministry or that die without having been examined by the official veterinarian (excluding anthrax), for productivity losses due to vaccine, serum and drug applications against diseases that must be reported and to animal owners who don't have these done to their animals although it has been decided by the Ministry that disease must be reported and vaccination, medication administrations or tests must be done. In the

cases listed above, prices of meat, skin and other parts of animals that are possible to be used and consumed are deducted from the compensation that they are eligible to get.

#### Vaccination and Ear Tag Supports

Unit prices specified in the table are paid to people carrying out the works (provided that contact with the business manager is ensured) for scheduled vaccinations and ear tag applications determined by the Ministry within the framework of fighting against animal diseases. #### Who can benefit from it?

Registered farmers that have less than 21 bovines or less than 51 ovines can benefit from this support.

#### Support Rates

Each bovine is paid 65 TL, and each ovine is paid 6.5 TL within the support program. Payments are made to farmers through Ziraat Bank.

#### Place and Date of Application

This support program is run by the Ministry of Agriculture and Forestry. Applications are accepted after 11/07/2020.

## Contracted Breeding Support

#### Purpose of the Support

The aim of this support is to decrease the idle capacities of existing breeding businesses, maintain red meat production, plan the supply of producers properly and set a model for the sector.

#### Who can benefit from it?

Breeders who sign a breeding contract with the Meat and Dairy Institution (ESK) can benefit from this support.

#### Support Rates

Payments are made for carcasses by Meat and Dairy Institution according to weight detailed below;

- 201-250 kg, 2.5 TL/kg
- 251-300 kg, 3,5 TL/kg
- Over 301 kg, 5.5 TL/kg

#### Place and Date of Application

This support is designed to be implemented for 5 years starting from September 2022. The implementing institution is the Meat and Dairy Institution (ESK).

• Contract conditions, determination of breeders, criteria and implementation of this support are made by Meat and Dairy Institution (ESK).

Seedlings and saplings must be obtained from authorized producer or seed dealer or they must be certified.

## Alternative Application Support for Areas with Potato Wart and Quarantine Line

#### Purpose of the Support

This support is given in order to support alternative practices recommended in areas where cultivation is banned because of potato wart.

#### Who can benefit from it?

Farmers registered in ÇKS can benefit from this support.

#### Subject and Rate of the Support

It is wanted to grow alternative products for consumption other than potato, seedlings, saplings or to fallow in contaminated areas that are found to be affected by potato wart and quarantined and quarantine line that are created by growing plant products other than potato and plants that are members of solanaceae family and production materials such as saplings, seedlings and tuber plants that will hold soil or by fallowing.

125 TL support is paid per decare. Support is paid once in three years.

#### Place and Date of Application

Farmers who want to benefit from the relevant support apply to provincial/district directorates where they have registered in ÇKS until 21/11/2022. Applications must be made within the relevant year and period. For detailed information, Notification No. 2022/32 should be checked.

## Support for Water Usage Service Fee for Agricultural Irrigation Purposes

#### Purpose of the Support

This support is given with the aim of reducing production costs and ensuring continuity of agricultural production by supporting the water usage service fee of farmers.

#### Who can Benefit from It?

Farmers registered in ÇKS can benefit from this support.

#### Subject and Rate of the Support

50% of the water usage service fee determined by the irrigation unions is paid by farmers to the irrigation union. The remaining 50% of the water usage service fee is paid to the irrigation unions on behalf of the producers from the budget of the Ministry of Agriculture and Forestry.

#### Place and Date of Application

This support starts on 1/1/2023 and ends on 31/12/2023. For detailed information, Presidential Decree No. 7179 should be examined.

## Support for Small Family Businesses' Producing Plants

With this support, 200 TL/decare is paid to small family businesses that are included in farmers register system and make plant production.

#### Purpose of the Support

With this support, it is aimed to support family businesses engaged in agricultural activities.

#### Who can benefit from it?

Enterprises that are registered in Farmers Register System (ÇKS) and whose agricultural land is 5 decares or less (more than 0.5 decare) in total can benefit from this support.

#### Supported Items and Rates

200 Turkish Lira family business support per decare is paid to real and legal persons cultivating fruit, vegetables, ornamental plants and medicinal and aromatic plants except for tea and hazelnut products in open area and/or greenhouse units.

#### Place and Date of Application

Farmers who want to benefit from the support apply to provincial/district directorates in the area where they are registered in Farmers Register System until 13/1/2023 from the date of publication of the relevant communication together with the petitions specified in the communication. For detailed information, Notification No. 2022/37 should be checked.

#### Other Statements Related to the Support

- Producers producing fruit, vegetables, ornamental plants and medicinal and aromatic plants in greenhouse units must be registered in Greenhouse Registration System (ÖKS).
- In case of more than one production in the main land/greenhouse units, support is given for only one production period.
- Support is not paid to enterprises with less than one decare of open production area and with 0,5 decare of greenhouse production area.
- If the lands whose share is more than five decares in the land registry is divided by means of renting and agricultural activity area becomes five decares or less, small family business support is not paid to these lands.

It is aimed to support organizations and persons that provide agricultural consultancy services to agricultural enterprises in order to ensure that system has a pluralistic, effective and efficient structure with support for agricultural extension and consultancy.

#### Who can benefit from it?

Free agricultural consultants, producer organizations and chambers of agriculture that employ consultants to serve agricultural enterprises can benefit from this support.

Within the scope of the support, agricultural enterprises that will receive agricultural consultancy services must be registered in relevant official registration systems and must meet at least one of the following criteria:

1) To carry out production in at least two decares of greenhouse area.

2) To carry out production in at least ten decares of vineyard-garden.

3) In field agriculture; to carry out production in at least one hundred decares of dry field or at least one hundred decares of dry and wet field on condition that more than half of it is dry and at least fifty decares of wet field.

4) In livestock; to have at least twenty cattle in dairy farms provided that ten of them are dairy cattle, at least fifty cattle in fattening cattle enterprises provided that there are at least twenty male animals and at least one hundred ovine animals in ovine breeding.

5) To have at least thirty bee colonies in bee keeping.

6) To have a aquacultural production facilities.

7) In poultry farming; to carry out farming at capacities of 5000 pieces in egg production, 10.000 pieces and more in meat production.

8) In organic farming, to have half of the operational sizes specified in paragraphs (1), (2), (3), (4), (5) and (7).

#### Supported Items and Rates

144,000 TL is paid from 2024 agricultural support budget in two equal parts depending on twelvemonth service provision for freelance agricultural consultants who provide agricultural extension and consultancy services by being authorized by the Ministry and for each agricultural consultant employed in the chamber of agriculture and producer organizations. An organization can benefit from support for maximum 5 consultants employed within its structure. Eligible expenses consist of personnel, office, material and other expenses. All of the support paid to the chamber of agriculture and producer organizations is used only as agricultural consultancy fee, tax and insurance expenses related to the fee and other expenses of agricultural consultancy activities are covered by the resources of the organization.

#### Place and Date of Application

Organizations that want to benefit from this support apply to district directorate in the area where agricultural consultancy service office is located or to the provincial directorate in the area where district directorate is not present, with necessary documents within ten (10) days from the publication of the relevant support communication. For detailed information, Notification numbered 2023/48 should be examined.

#### Farm Accounting Data Network System

#### Purpose of the Support

With this support, it is aimed to support agricultural enterprises that are voluntarily included in Farm Accounting Data Network (ÇMVA) system, share and update data.

#### Who can benefit from it?

Payments are made to agricultural enterprises that are registered in Farmers Register System (ÇKS) and/or any administrative registration system created by the Ministry, that are included in ÇMVA

system, that share accounting data related to their agricultural activities with data collectors in a specified period during an accounting year and whose data is sent to the Responsible Unit.

#### Supported Items and Rates

1,000 TL participation support is paid per business in a year.

#### Place and Date of Application

Applications are made to Provincial Directorates of Agriculture and Forestry. Applications are always active. For detailed information, Notification numbered 2022/45 should be checked.

### Supports for Agriculture Insurance

#### Purpose of the Support

With support for agriculture insurance, it is aimed to provide a certain amount of insurance support in order to compensate and secure losses that producers may suffer because of certain risks.

#### Who can benefit from it?

Producers who want to benefit from this support must be registered in systems such as Farmers Register System (ÇKS), Greenhouse Registration System (ÖAKS), Livestock Information System (HAYBIS), Fisheries Registration System (SKS) depending on the content of the support.

For plant products, full hail package is created with additional storm, hurricane, fire, landslide, earthquake, flood, vehicle crash, harms given by wild boar to field crops, vegetables and strawberry products and frost damage to be paid as replanting cost risks together with main hail risk. In addition to these risks, optionally;

- a) Frost risk for rose for oil and fruit types grown in open field,
- b) Anti hail nets, cover and support (wired finish) systems and products under these systems against hail weight, natural disasters and vehicle crash risks,
- c) Rain risk for cherry, fig and grape products,

- d) Frost damage to be paid as replanting costs in sugar beet, squash, tomato, pepper, eggplant, watermelon and melon products,
- e) Hot weather risk for grapefruit, tangerine, orange and grape can be guaranteed by Agriculture Insurance Pool.
- With village based drought yield insurance, in wheat, barley, rye, oat, triticale, chickpeas, red lentils and green lentils grown in dry agricultural areas and certified seeds of these products, yield decreases because of frost, hot wind, heat wave, excessive humidity, excessive precipitation risks outside of hail package are guaranteed by Agriculture Insurance Pool within the scope of the relevant general conditions and tariffs and instructions by considering personal, product and land information of the farmers registered in Farmers Register System.

#### Greenhouse Insurance

- Earthquake, vehicle crash, storm, hurricane, fire, landslide, flood, snow and hail weight risks can be guaranteed together with main hail risk in accordance with the result of risk analysis and assessment for greenhouse building materials, technical equipment and plant products grown in the greenhouse.
- In order for farmers to make insurance transactions, first of all, they must update information related to greenhouse and products in there for that year in Greenhouse Registration System.
- Farmers who have updated their records apply to insurance companies or agencies that are members of Agriculture Insurance Pool (TARSIM) to have their products insured.

#### Bovine Life Insurance

- Death risk for registered bovine animals and optionally, additional theft, terrorism or similar risks are guaranteed by Agriculture Insurance Pool by considering current facility, enterprise and breeding information within the scope of relevant general conditions and tariffs and instructions.
- To have their bovine animals that are registered in Livestock Information System (HAYBIS) insured, breeders apply to insurance company or agency that is member of Agriculture Insurance Pool (TARSIM).

#### Ovine Life Insurance

- Death risk for registered ovine animals and optionally, additional theft, terrorism or similar risks are guaranteed by Agriculture Insurance Pool by considering current facility, enterprise and breeding information within the scope of relevant general conditions and tariffs and instructions.
- To have their sheep, goats, rams or male goats that are registered in Livestock Information System (HAYBIS) insured, breeders apply to insurance company or agency that is member of Agriculture Insurance Pool (TARSIM).

#### Poultry Life Insurance

 Death risk for poultry that is raised in facilities that are registered in the Ministry's registration systems, produce in closed system and where biosafety and hygiene measures are taken and death risk for poultry raised in open and semi-open systems are guaranteed by considering current facility, enterprise and breeding information within the scope of relevant general conditions and tariffs and instructions.

#### Fisheries Life Insurance

Disease risk for fisheries in seas and inland waters, uncontrolled pollution and poisoning, predator attacks, storm, hurricane, earthquake, flood, accidents and algea risks can be insured. Optionally;

- Accidents, predator attack, storm, tornado, earthquake, flood and flood risk for cages and nets,
- Theft risk for fisheries, cages and nets can be insured.

#### Bee Keeping (Hive with Bees) Insurance

- Modern and active hives (with bees inside) that are registered in Bee Keeping Registration System (AKS) and that have plates, are covered by the insurance.
- With this insurance, active hives (with bees inside) are insured against damages caused by storm, hurricane, fire, landslide, earthquake, vehicle crash, flood, wild animal attack, crash, collision, tipping, burning, etc. during the transportation of hives.

#### Costs that are not supported

Facilities, enterprises, products and risks that are not deemed appropriate to be insured by Agriculture Insurance Pool as a result of the risk analysis, can't be insured.

#### Place and Date of Application

Place of application for this support which is open all year round, is insurance companies or agencies that are members of Agriculture Insurance Pool (TARSİM). In order for the producer to carry out insurance transactions, land and product information of that year must be updated in Farmers Register System (ÇKS) and other relevant registration systems.

#### Other Statements Related to the Support

Optional additional guarantees can't be taken alone.

Full damages caused by hail, storm, hurricane, fire, earthquake, landslide, flood, vehicle crash and snow weight risks on fruit trees and vineyards and their saplings becoming fruitful, can be insured with or independently from the product.

## Research and Development Support

#### Purpose of the Support

In priority issues needed by the Ministry of Agriculture and Forestry and agricultural sector, this support aims:

- To develop private sector's R&D culture and capacity,
- To develop new species, varieties, technologies, models, products, etc.
- To transfer outputs to farmers and agricultural industrialists.

#### Who can benefit from it?

Universities, TÜBİTAK R&D units, non-governmental and professional organizations and private sector can apply for this support. Real persons, sole proprietorships and ordinary partnerships cannot apply for a project.

#### Research Subjects and Support Amount

The upper limit of support is 300,000 TL for universities, TÜBITAK R&D units and 3,000,000 TL for for private sector. The support rate is 100% for universities and TÜBITAK R&D units and 70% for private sector, vocational and non-governmental organizations.

- Minimum 10, maximum 50 buffaloes or
- Minimum 100, maximum 500 sheep/goats

For new enterprises and existing agricultural enterprises that increase capacity, support rate is 40%.

Support rate increases by 5% if the applicant is under 40 years old, 5% if the investment is carried out in the mountainside and 10% if both conditions are fulfilled together.

#### Supported Costs

Machine and equipment purchases, visibility expenses, service and consultancy expenses are supported. Eligible expenses are exempt from tax.

- Minimum 5.000 Euros and maximum 125.000 Euros for goose sector

Agricultural enterprises that produce poultry meat shouldn't exceed capacity limits stated below at the end of the investment:

- Minimum 5.000, maximum 50.000 broilers or
- Minimum 1.000, maximum 8.000 turkeys or
- Minimum 350, maximum 3.000 geese

While active existing enterprises that don't include capacity increase in "broiler" applications are within the scope of the support, new enterprises are out of the scope of the support in Konya.

Enterprises that produce eggs shouldn't exceed capacity limits of minimum 20.000 and maximum 100.000 layer hens at the end of the investment.

Only existing agricultural enterprises that are active in egg production and fulfill the following conditions are eligible provided that they don't increase their capacities:

- Enterprises that need renewal in their facilities and equipment
- Enterprises carrying their facilities away from residential areas (in the same province)
- Those expanding buildings in order to fulfill animal welfare conditions without increasing the capacity

At the end of the investment, enterprises processing milk and whey should have minimum 10 tons of daily capacity. There are no upper and lower limits for milk collection centers.

At the end of the investment period, investment must meet occupational safety, EU hygiene (except for raw milk) and structural standards (based on EC 852/2004, EC 853/2004) and EU environment standards.

Red meat slaughterhouses must have a daily slaughtering capacity of 30-500 bovine or 50-4.000 ovine animals at the end of the investment. Daily capacity for meat processing facilities and cutting facilities must be between 0,5 and 5 tons.

#### Supported Costs

Machine and equipment purchases, visibility expenses, service and consultancy expenses are supported. Eligible expenses are exempt from tax.

Refrigerated vehicle (motor vehicle with cooling tank/body) are also included in the scope of the support.

#### Costs that are not supported

Construction works, land/building purchase, second hand machine and equipment purchase, rent expenses, operating expenses, animal purchase, tax maintenance/amortization expenses and insurance expenses are among ineligible expenses.

Poultry meat slaughterhouses must have a hourly slaughtering capacity of 1.000-5.000 chickens or 100-1.000 turkeys at the end of the investment. Daily capacity for meat processing facilities and cutting facilities must be between 0,5 and 5 tons.

Machine and equipment purchases, visibility expenses, service and consultancy expenses are supported. Eligible expenses are exempt from tax.

Refrigerated vehicle (motor vehicle with cooling tank/body) are also included in the scope of the support.

#### Costs that are not supported

Construction works, land/building purchase, second hand machine and equipment purchase, rent expenses, operating expenses, animal purchase, tax maintenance/amortization expenses and insurance expenses are among ineligible expenses.

At the end of the investment; processing facility must have an annual processing, production capacity of 100-2.000 tons of fisheris, fish oil or mollusca, bivalves and crustaceans.

Machine and equipment purchases, visibility expenses, service and consultancy expenses are supported. Eligible expenses are exempt from tax.

Refrigerated vehicle (motor vehicle with cooling tank/body) are also included in the scope of the support.

#### Costs that are not supported

Construction works, land/building purchase, second hand machine and equipment purchase, rent expenses, operating expenses, animal purchase, tax maintenance/amortization expenses and insurance expenses are among ineligible expenses.

## 103-5 Fruit and Vegetable Processing and Marketing Program

All legal and real persons that are defined as small and medium sized enterprises are defined as eligible beneficiaries.

Support rate is 55% of the expense amount. Support rate is 65% for producer organizations and legal persons for which producer organization is controlling shareholder.

The part exceeding upper limits is not supported and excess amount is covered by the applicant.

The part exceeding upper limits is not supported and excess amount is covered by the applicant.

For honey and bee products, number of hives to be reached within the scope of the investment is limited to minimum 30 and maximum 500 hives per beneficiary to be realized during final payment request.

Limitation on the number of hives will not be taken into consideration for processing and packaging of honey and bee products and production of hives.

Construction works, machine and equipment purchases, visibility expenses, architecture, engineering and consultancy expenses, general expenses for obtaining license and patent rights are supported. Self-propelled and/or motor vehicles were added as eligible expenses in purchase of agricultural machinery, tools and equipment in 2020. Eligible expenses are exempt from tax.

It includes investments to be made for electricity and heat generation. Upper and lower eligible expense limits for investments within this scope are minimum 5.000 Euros and maximum 500.000 Euros. Exchange rate of Euro is determined as 1 Euro = 14.31 TL. Support rate is 55% of the expense amount. Support rate is 65% for producer organizations and legal persons for which producer organization is controlling shareholder.

All kinds of renewable energy activities (except for hydroelectricity) for electricity and heat generation purposes including below mentioned ones are eligible:

- Photovoltaic solar energy systems
- Concentrate solar energy systems
- Wind energy systems
- Geothermal, biomass, microgeneration systems

Within the scope of the support, energy investments up to 5 MW capacity will be supported. This amount has been determined as 100 kWe for micro-cogeneration.

- Share of the entrepreneur in the business he established must be minimum 50%,
- In the support process of the entrepreneur, he mustn't work in another enterprise/institution/organization by being subject to provisions of SSI.

aromatic plants (thyme, rose for oil, lavender for oil, lemon balm, ginger, sahlep, rosemary, sage, sweetgum oil, sumac, carob, laurel, basil, blueberry, aronia, linden, saffron and jojoba) must be grown.

- Real and legal person businesses that will benefit from the loans under "Processing of Agricultural Products" must be at the scale of "micro business" or "small business".
- For detailed information, see communication no 2020/4, Presidential Decisions no 8038 and 8039.

## Credit Guarantee Fund (KGF)

After rating to be performed within the structure of KGF A.Ş., Credit Guarantee Fund provides guarantee for loans to be made available by the Bank for SMEs engaged in economic and commercial activities and tradesmen, artisans, self-employed members, cooperatives (excluding land and residential building cooperatives), farmers having these qualifications and real or legal persons having the qualifications specified in the Articles of Association of Credit Guarantee Fund.

#### Scope and Details

For SMEs in equity guarantees:

- Period for working capital loans is minimum 6 months, maximum 60 months, payment free period is maximum 1 year.
- Period for investment loans is minimum 6 months, maximum 84 months, payment free period is maximum 2 years.
- Period for benefiting from the guarantee is 1 year beginning from the date when Credit Guarantee Fund issues guarantee.
- Guarantee limit in favor of each beneficiary/group is maximum 3 million TL and maximum guarantee rate is 80%.

**Important Note:** Institutions that have protocols with KGF are KOSGEB, Ministry of Industry and Technology, Technology Development Foundation of Türkiye and TÜBİTAK. For the loans to be used under KGF guarantee, the term, rate and maximum amount of the guarantee may differ depending on the source used for the guarantee, the protocol made with the supporting institution and the characteristics of the beneficiary. Website should be checked for details.

#### Fee and Commission

- 2% guarantee commission is received in advance based on Credit Guarantee Fund's guarantee amount at the moment of providing loan for the first year and based on guarantee risk for every year in the following years.
- If the loan to be made available to the beneficiary is one of the corporate finance support loans such as Bank Overdraft/Rotating, Direct Debiting System, Participation Banks' Checking Account, guarantee commission is received in advance at the rate of 2% based on the guarantee limit of Credit Guarantee Fund for each year.
- It is received at the rate of 1% based guarantee amount in temporary and final guarantee letters for the commitment services.

#### Application conditions

Beneficiary must be a real or legal person possessing business with SME qualification.

Applications are made through banks under agreement.

## General Directorate of Forestry Special Afforestation Supports

#### Purpose of the Support

This support is provided by the General Directorate in order to increase the forest area, to improve biodiversity and to reconstitute degraded forest ecosystem. It includes afforestation, erosion control, pasture improvement, rehabilitation, nursery, tree breeding, seed and sapling production and development-improvement works.

#### Who can benefit from it?

Real and legal persons can benefit from this support if they fulfill the relevant conditions.

#### Terms of the Support

Grant is given to real and legal persons by the General Directorate as foreseen in the Regulation on Afforestation and Erosion Control Services for tree and shrub species producing essential or non-wood forest products in degraded forest areas, openings in the forest, in treasury lands, in lands owned by the State and in owned lands and for special reforestation and special development-improvement works they do and private forest nurseries according to approved application project.

Grant at the amount of 65% of the amount of grant based investment expenses table may be given to real persons who are registered in the forest village population and reside in that village for tree and shrub species producing non-wood forest products in degraded forest areas, openings in the forest, in treasury lands, in lands owned by the State and in owned lands and for special reforestation and special development-improvement works they do up to 3 hectares just once according to approved application project. Grant at the amount of 25% of the amount of grant based investment expenses table may be given to real and legal persons who are not registered in the village.

Forest tree and shrub saplings may be given free of charge by the Regional Directorate at the amount specified in the approved application project for special erosion control works to be carried out by real or legal persons and special afforestation and special development-improvement works to be carried out without requesting a grant.

In special afforestation and special development-improvement works carried out by real or legal persons with trees and shrub species producing essential forest products in pure or mixed forms; grant up to 25% of total of costs and workmanship of wooden environing pile or equal arm (L) or (T) figured iron fence post, barbed wire, connection or fixing materials, three-year maintenance and project construction costs may be given.

In special afforestation and special development-improvement works carried out by real or legal persons by using species producing non-wood forest products such as walnut, chestnut, pistachio, almond, carob, hawthorn, laurel, mahaleb, olive, rosehip and gumwood and fast growing forest tree and shrub species such as poplar, alder, eucalyptus, etc. in pure or mixed forms; grant up to 25% of total of environing, revitalization cut, land preparation, planting or sowing, seed, cutting for grafting, bud eye and grafting, sapling costs, drip irrigation facility cost, three-year maintenance and project construction costs may be given.

In the grant based investment expenses table included in their certified project and approved by Nursery Directorate for private forest nurseries to be established by real or legal persons; grant up to 25% of total of environing, drainage, leveling, greenhouse establishment, installation of outdoor irrigation installation, growing environment, growing container, tillage, production material, workmanship, three-year maintenance and project construction costs may be given.

In special afforestation and special development-improvement works to be carried out by persons registered in the forest village population and residing in that village by using tree and shrub species producing non-wood forest products; grant up to 65% of total of environing, revitalization cut, land preparation, planting or sowing, seed, cutting for grafting, bud eye and grafting, sapling costs, drip irrigation facility cost, three-year maintenance and project construction costs may be given.

#### Place and Date of Application

Applications for special afforestation and special development-improvement in state owned forests are made to the relevant directorates in 2 periods in April and September. For detailed information, it is necessary to contact relevant directorates.

#### Other Statements Related to the Support

In private forest nurseries for which grants are allocated, minimum fifty percent (50%) of saplings to be produced must be forest tree and shrub saplings and maximum fifty percent (50%) of them must be species producing non-wood forest products and ornamental plants.

## Forestry and Village Relations Department ORKÖY Loans

#### Purpose of the Support

The purpose of Support Program for Development of Forest Villagers is to contribute to development of forest villagers and to reduce pressure on forests in order to achieve the objectives of conservation, development, operation and expansion of forests.

#### Who can benefit from it?

Forest villagers, cooperatives and cooperative higher organizations can benefit from this program. Forest villagers are required to have lived in villages at least for 1 year.

#### Scope of the Support

Loan upper limits are decided by the general directorate of forestry. Loans are given to the beneficiary without interest.

#### Loan Support for Individual Use

Supported areas are divided into two main categories as "Social" and "Economic" loans. These loans are 3-7 year credits. The grant rate for 2023 is 20%. For economic loans, a contribution of at least 10% of the project amount is required.

#### Loan Support for Cooperatives

These loans are 3 to 8 years interest free credits. According to the project subject, equity contribution is required between 5 to 25 percent. Project subject and loan limits are determined specially by the Ministry.

#### **Application Place**

Applications are made online via e-devlet. Applications are accepted across the year.

#### Other Statements Related to the Support

- At least 10% of villager contribution is required for economic loans.
- Except micro loans for housewives, only one family member is given loan.
- Equity capital contribution at the amount of five percent (5%) of total project amount is sought in new projects related to non-wood forest products for economic purposes to be implemented by cooperative or cooperative higher organizations, at the amount of minimum ten percent (10%) of the project amount in other new investment projects and business capital projects with economic purposes and at the amount of minimum twenty five percent (25%) of the project amount in modernization and expansion projects. Land share can't exceed five percent (5%) of the project fixed investment amount.
- Cooperatives participating in the project must be established in forest villages.
- Equity contribution is not required for social project of cooperatives or higher cooperative institutions.
- Beneficiaries who pay their loans properly can have loans again.
- Investment period cannot exceed 3 years.
- In order to benefit from personal loans, it must be documented that they are forest villagers and not permanent workers/civil servants/tradesmen.
- With acceptable reasons, installments can be postponed one time for individuals for 12 months, two times for cooperatives (or higher cooperative bodies) for 15 months.

#### Other Statements Related to the Support

General investment incentive certificate may be issued for the investments providing the following minimum conditions:

- Minimum 150 bovines for integrated investments for meat-oriented, dairy-oriented and breeding bovines,
- 100.000 pcs/period for integrated poultry investments,
- 1.000 ovines/period for integrated dairy and meat-oriented ovine investments (including breeding stock),
- Dairy processing investments with 5 tons/day production capacity,
- Greenhousing investment larger than 5 decares.

Agricultural investments which can benefit from the regional supports provided for the second region including Konya are grouped by considering minimum investment amounts or capacities in the following table.
