SHORT **ANALYSIS OF** KONYA FOR INVESTMENT

Konya;

- ·Konya province is located in the south of Central Anatolia Region with a population of 2.2 million.
- Konya is the largest province of Turkéy and covers approximately 5% of the country's territory.
- In terms of geographical location, it is established on the roads connecting Mediterranean Region to Central Anatolia and Aegean Region to East and Southeast and there are road, railway and airway transportation opportunities.
- ·With its location in the center of Anatolia, it provides easy access to 15 billion customers in Europe, Eurasia, Middle East and North Africa
- ·With access opportunity by means of high speed train, it is located on connection point of South-North and Southeast-West railway line.
- ·Konya-Mersin Railway Line and Antalya-Konya-Aksaray-Nevşehir-Kayseri Accelerated Train Line are planned to be completed until 2023. With completion of this line, Konya's distance to the ports will not be a problem.
- ·Konya Airport is an international airport. Konya Airport is in the category of civil-military airport and it is 18 km away from the city. Konya Airport is among the

airports where cargo transportation is performed.

- ·Konya is a province experiencing problems in terms of water resources in Turkey. Projects works regarding water transfer to Konyă Clošed Basin from outside that are planned to be put into use in the future. continue.
- It is a production base that makes serious contributions to the national economy and that is locomotive to other provinces in the region as an attraction center in both Turkey and Central Anatolia Region in terms of agriculture, trade, industry and tourism.
- ·Presence of suitable pasture and forage plant production areas and presence of land in suitable size for livestock are important advantages for the sector.
- ·With its tourism potential, it has provided a basis for important investments in the sector.
- It has suitable conditions for investment with its foreign trade volume, wide export network, historical and cultural background, industrial infrastructure, well-educated and dynamic young population.

Reasons for Industrial Sector Investments

Young, Dynamic, Educated **Population**

47,7% of the population of 2.2 million people is human capital under the age of 35.

There are 5 universities (Selçuk University, Necmettin Erbakan University, Konya Technical University, KTO Karatay University, Konya Food and Agriculture University).

Konya is in the fourth place in our country with 132.802 students.

There are 28.000 students in vocational and technical high schools.

Full-flexible time and part-time working cultures have been established.



With the advantage of its strategic location, it has a structure providing easy access to its customers in Europe, Eurasia, Middle East and North Africa and suitable for intermodal transportation.

It has road connections with important centers such as Adana, Ankara, Antalya, İstanbul, İzmir, Mersin and Eskişehir.

High Speed Train (YHT) operations are carried out between Ankara-Konya, Eskişehir-Konya, İstanbul-Konya. In addition to YHT lines, trains passing through Konya are Taurus Express (Konya-Adana) and Konya Blue Train (Konya-İzmir).

Kayacık Logistics Center Project that will offer services to investors at international standards together with Konya Organized Industrial Zone, is planned to be completed at the end of 2020.

Konya airport operates internationally.





Richness in Terms Of Natural Resources

There are many underground resources in Konya such as aluminum, magnesite, lignite, coal, clay, cement raw materials, marble, lead, zinc and barite.

Konya has an important place in salt production.

Reserves of sodium sulphate and potassium sulphate used in glass, leather, chemical and paper industries.

There are geothermal water resources with different features.

It has rich reserve of olivine which is used in many sub-industries that require high temperature, especially in iron and steel industry, cement sector.



There are potential areas where wind power plants can be installed.

It has a large and nonarable land stock for solar power plant and high potential in terms of insolation values.

In Konya-Karapınar District, lands were determined to be allocated for solar energy investments by declaring "Energy Specialization Industrial Zone". There are Solar Power Plants in 3 locations in Konya

Organized Industrial Zone with a total of 4,5 MW; 65-85% of energy needs of the facilities and district lighting are met from these plants.

- > There are rich rock gas reserves.
- > With renewable energy resources, energy source diversity and security of supply are targeted.

Industrial Infrastructure Advantage

There are 9 Organized Industrial Zones, 48 Small Industrial Areas and 22 Private Industrial Areas in Konya.

There is an infrastructure suitable for Defense Industry.

Konya is in 5th place in trademark registration, in 5th place in

industrial design registration and in 6th place in patent registration.

Konya has a strong position in domestic market due to its regional advantage.

It has flexible production capability and industry adapting to changing technologies.

> Reasons for Agricultural Sector Investments

Young, Dynamic and Educated Human Resource

Konya province's population is 2,2 million.

Food and Agriculture University which is the only one in its field in our country, is located in Konya.

Presence of suitable vocational course opportunities and faculties that train students for the agricultural sector.

Presence of experienced personnel working in the sector.

Konya hosts Konya Agriculture Fair that is one of the largest agriculture fairs in Turkey.

Strategic Location and Presence of Wide Land

Agriculture is carried out on 1.890.829 hectares of land in Konya.

19,9% of Konya's existing area consists of meadow-pasture and 12% consists of forest areas.

In our country, 98% of tulip production, 66% of carrot production 29% of sugar beet production, 24% of white bean production and 12,5% of total cereal production are met by Konya.

There are private property lands at affordable cost

There are large public lands suitable for agricultural investment.

Konya Plain Project Regional Development Administration has been assigned to coordinate public been assigned to coordinate public **Project** investments for development of the region and to prepare Konya Plain Project Action Plan within the

framework of public investments, projects and activities.

37.000 ha of open network irrigation infrastructure will be converted into a closed system.

It is planned to increase total irrigated area in Konya Plain Project Region from 924.000 ha to 1.100.00 ha.

It is planned to increase consolidated agricultural area to 1.392.000 hectares.

Pasture improvement work will be completed in 20.000 ha of area and green fertilizer will be applied in 10.000 ha of area annually.

Konya is a suitable city in terms of wide and irrigable lands.

Anatolia's first seed fair is held in Konya.

High quality seeds are produced in various products. Development in Seed Sector

Bahri Dağdaş International Agricultural Research Institute which is specialized in seed, is one of the important centers for Konya.

Strong companies operating in the field of seed and their knowledge lead the sector.

Livestock **Potential**

There is an Organized Livestock Zone established on an area of 21 million square meters in Konya's Çumra district, 30 kilometers away from the city center.

Aquaculture and fishing potential is high especially in Beyşehir Lake Basin.

INVESTMENT SUBJECTS RECOMMENDED

While investment subjects suitable for Konya province are recommended, factors such as Konya's geographical location, socio-economic development level, natural resource potential, agricultural production potential, intensity of industrial production and FOR KONYA commercial activities, domestic demand and foreign demand and development dynamics of the province are considered.

1	Mining Sector	Marble, lignite, sand-gravel, bentonite, clay, kaolin.
2	Energy Sector	Wind Power Plant, Solar Power Plant.
3	Agricultural Sector	Cultivation in greenhouse, forage crop cultivation, bovine-ovine breeding, licensed warehousing.
4	Manufacturing Sector	Food Products: Milk products, red-white meat, chocolate-confectionery, vegetable-fruit drying-processing-packaging facility, vegetable-fruit juices. Leather Processing: shoes-suitcase-handbag production). Paper Products Production: Corrugated cardboard, cardboard box production, folding box from paper-cardboard without corrugation, parcel production). Manufacture of Plastic-Rubber Products: Items such as plastic sprinkling-irrigation equipment, PVC joinery, plastic dispenser size bottle, bottle etc., plastic box, case, crate, etc. Manufacture of Chemical Substance and Products: Adhesive, chemical anchor, liquid detergent, powder detergent, nitrogenous mineral or chemical fertilizers. Except for Machine and Equipment: Fabricated metal products manufacturing, motor land vehicles, aluminum conductor manufacturing, aluminum railing systems, prefabricated building elements made of metal. Manufacture of Machine and Equipment not Classified in Anywhere Else: Manufacture of Solar power systems, various agricultural tools and machines, water treatment and mineralization device, mill and flour machines, chocolate-confectionery machines-molds, plastic-aluminum-metal mold, auto headlight and signaling elements, plug in cable-insulated electrical cable. Manufacture of Non-Metallic Mineral Products: Production of ready-mixed concrete, briquette and hollow block, manufacture of pumice block and concrete parquet, prefabricated building elements, heat insulated double glass, tempered glass. Manufacture of Motor Land Vehicle-Trailer and Semi-Trailer: Parts and accessories related to engines of motor land vehicles, truck bed, trailer, dumper, commercial vehicle air conditioners, rim, trailer rotors, trailer lifts, differential, engine, transmission and brake spare parts, tractor parts and accessories. Medical Tools: Manufacture of watches with precision and optical tools.
5	Service Sector	Storing: Cold storages, legume packaging-storing, seed storing-classification-packaging, cereal storage services, packaging and labeling services, egg sorting and packaging, student dormitories, five star-four star hotel, surgical hospital services, medical waste sterilization, plastic recycling.

All investments to be made in Konya over 1.000.000 TL, except for the investment subjects that will not be supported and can't meet the conditions for the incentive benefit from:

INVESTMENT INCENTIVE SYSTEMAND KONYA

- VAT Exemption
- Customs Duty Exemption supports.

Investments to be made in Konya:

If the investment is in OIZ or if it is an investment that will provide integration in the field of joint activity and realized by the investor with at least five partners that are real or legal persons operating in the same sector, it benefits from supports of the 3rd region which is a sub-region, in terms of tax reduction and insurance premium employer's share support.

If it is one of the priority investment subjects, it benefits from supports of 5th Region.

investment, it benefits from VAT exemption, customs duty exemption and interest or profit share supports. If it is R&D and environmental investment, it benefits from VAT exemption, customs duty exemption and interest or profit share supports. Investments for production of products in medium-high technology industry class according to OECD technology density definition benefit from regional supports applied in 4th Region. In these investments, minimum fixed investment amount is 1 million TL for Konya.

In addition, VAT refund is refunded in building-construction expenses for investment expenses to be made between 1/1/2017 and 31/12/2021.

District Based Incentive System

The first step was taken for district based classification in incentive system and design incentives on a district basis with Presidential decision amending "Decision on Government Supports in Investments" published in Official Gazette on August 21, 2020. According to the decision published in Official Gazette, districts of 53 provinces that have been determined will be able to benefit from the incentive.

Selection criteria of the districts to which incentives will be given in the subgroup of the province where they are located have been implemented as being below the development level of the province where they are located. When investment

is made in OIZs of districts selected, it will be benefited from two sub-region incentives. Meanwhile provinces in the 6th Region benefiting from the highest incentive are excluded as they are not sub-regions.

Districts that can benefit from a lower incentive group in Konya according to District Based Incentive System are as follows; Ahırıl, Altınekin, Bozkır, Çeltik, Derebucak, Derbent, Doğanhisar, Emirgazi, Güneysınır, Hadim, Halkapınar, Hüyük, Kadınhanı, Kulu, Sarayönü, Taşkent, Tuzlukçu,

Yalıhüyük, Yunak.

Although Konya is located in the 2nd Region in the current situation, it will be benefited from 3rd Region incentives for the investments to be made in the above mentioned 19 districts and if investments are made in OIZs of the districts, it can be benefited from 4th Region incentives.
