






GOVERNMENTAL INCENTIVES THAT INVESTORS IN OIZ CAN BENEFIT FROM

Property Tax Exemption: It covers all buildings in OIZs. (on condition that it is not used for the rent) VAT Exemption: It covers infrastructure investments and land deliveries of OIZs.

VAT Exemption: It covers contracts and undertakings regarding the allocation of lands in OIZs.

Fee Exemption: It covers the fees of the amalgamation, subdivision, transfer-registration and type change classification of the Real Estates in the OIZs, and their Building construction and utilization permit fees.

Benefiting from a Sub-Region Support within the Scope of the Decision on Government Supports in the Investments: Benefiting from a Sub-Region Support (Benefiting from two sub-region supports in OIZs located in the Districts specified in the Annex No. 7 of the Decision)

Land Allocation Support: Participants who guarantee employment for at least ten people can benefit from it. Authorized body of the relevant OIZ must give the decision.

Discount for Service Fee to be Paid to Building Inspection Authorities: Discount is made provided that such discount is not more than 35%.

ADVANTAGES OF BEING AN INDUSTRIAL REGION FOR INVESTORS

- Depending on the project, Ministry may cover the costs related to the infrastructure required to prepare the zone for investments. (This advantage is provided only for Mixed/Specialized Industrial Zones managed by the Managing Company. The applicant covers all infrastructure expenditures in Individual Investment Area and Private Industrial Zones.)
- The areas subject to private property may be expropriated by the Ministry. The Ministry may cover the expenses regarding expropriation.
- Ministry approves present maps, geological-geotechnical investigation report, zoning and subdivision plans, infrastructure and superstructure projects. It doesn't charge fee for these.
- Ministry issues building license, residential usage license and business license. It doesn't charge any fee for such permits and licenses.
- "EIA isn't Necessary" or "EIA Positive" decision required for the investment is taken within 2 months at the latest.
- Approvals and permits issued by our Ministry and other permits, approvals and licenses required to complete the investment and enable the facility
 to start production except for EIA permit are issued by the relevant institutions within 15 days.
- Right of easement and utilization permit for public land are given for a period of 49 years. (Outside Industrial Zone, this period is maximum 30 years.)
- Right of easement or utilization permit fee is determined at the rate of five per thousand (one per thousand in case of strategic investment) of the total unit value of the minimum square meter of the immovable based on the property tax. (Outside Industrial Zone, it is applied as two percent of the current market value at the least.) A minimum of 8 times more discounted right of easement can be established when compared to public lands outside the industrial zone.)
- Investments that receive Investment Incentive Certificates can benefit from these supports in terms of tax reduction and insurance premium employer share support for the rates and periods provided in a sub-region of their region.
- All buildings in the region are exempt from property tax.
- Contracts and undertakings issued related to allocation of the lands are exempt from stamp tax.
- Subdivision or division or merging of real estates located in the zone, processes that require annotation due to the allocation of the lands in the relevant zones, transfer and registration processes of this land and the buildings built on it, and type change processes are exempt from fees.
- In accordance with Article 4Ç of the Law on Industrial Zones No. 4737, President may determine additional incentives for Private Industrial Zones. (This advantage is provided only for Private Industrial Zone. Investors in other industrial zones may benefit from incentives within the scope of the current Investment Incentive Decision.)





PROMINENT INVESTMENTS





Started in June 2013 with €95 million investment, Algida produces ice cream for Türkiye, Middle East and Africa.



Home and personal care products factory was opened in May 2017. Unilever, which created a strong supply chain ecosystem in Konya with its suppliers, made an integrated investment of 350 million Euros in total.



TÜMOSAN was established in 1976 to produce engine, transmission parts and similar equipment. The firm later concentrated its activities on the production of diesel engines and tractors. Today, it is one of the biggest production facilities of Türkiye with 75,000 engines and 45,000 tractor production capacity per year.



Metro Wholesaler Market chain opened its 12th store in Konya in November 2008 with an investment of 20 million Euros.



In March 2019, ASELSAN Konya Weapon Systems Inc. laid the foundation of the factory where remote controlled weapon systems and weapons will be produced. An investment of 65 million dollars has been made.



PROMINENT INVESTMENTS





It's Türkiye's only integrated aluminum factory which obtains aluminum ore and produces from the mine to the final product. Since its privatization in 2005, it has been built almost from the beginning with an investment of 580 million dollars. It can provide 10% of the needs of Türkiye.



It is a food production giant that started with chocolate products in 2007 and expanded its product range from frozen potatoes to milk and meat products, from bulgur to fruit juice, from vinegar to various beverages. It is a Konya Sugar brand powered by 900 thousand farmers.



It is the World's largest single field solar energy investment in Karapınar region. With an investment of 1 billion dollars, 1,300 MW of electric power will be obtained by 2023. It is carried out in Karapınar Energy Specialized Industrial Zone.



It is an energy company belongs to the Mutlu Group of Companies. In 2019, it made a wind power plant investment of 44 MW with an investment of 370 million liras.



In 1975, it began production as Türkiye's first suspension and steering parts manufacturer. Today, it is one of the world's leading original and spare parts manufacturers with an annual production capacity of over 36 million and a product range of more than 30,000.





Pays at least 500.000 USD or its equivalent in foreign currency into the private pension system, provided that he/she keeps it in the funds established by the Insurance and Private Pension Regulation and Supervision Agency
